- Carbonated soft drinks market includes retail sales of carbonated drinks. However, the total market volume for carbonated soft drinks market excludes powder concentrates, which are included in the market value. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Singaporean carbonated soft drinks market recorded revenues of \$241.9 million in 2024, representing a compound annual growth rate (CAGR) of 2.5% between 2019-24.
- Market consumption volume increased with a CAGR of 1.5% between 2019-24, reaching a total of 149.6 million liters in 2024.
- The Singaporean carbonated soft drinks market registered moderate growth during 2019-24, primarily driven by Singapore's strong health consciousness, coupled with the Nutri-Grade labelling and sugar-reduction regulations introduced in 2022-23, restricted growth in traditional high-sugar carbonates, and growing consumers' attraction toward bottled water, teas, zero-sugar options, and functional beverages.
