- The Spanish carbonated soft drinks market recorded revenues of \$6,227.3 million in 2024, representing a compound annual growth rate (CAGR) of 2.9% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2019-24, reaching a total of 3,305.3 million liters in 2024.
- The Spanish carbonated soft drinks market registered moderate growth during 2019-24, primarily due to the rising inflation, which led to a significant increase in the cost of essential goods, prompting consumers to reduce discretionary spending.
