However, the total market volume for carbonated soft drinks market excludes powder concentrates, which are included in the market value. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Dutch carbonated soft drinks market recorded revenues of \$2,715.8 million in 2024, representing a compound annual growth rate (CAGR) of 4.2% between 2019-24.
- Market consumption volume increased with a CAGR of 0.3% between 2019-24, reaching a total of 1,008.0 million liters in 2024.
- The Dutch carbonated soft drinks market registered strong growth during 2019-24, primarily driven by the rising disposable incomes, higher purchasing power, an increasing number of food processing facilities, warm weather, and substantial consumption from an expanding population.
