- The UK carbonated soft drinks market recorded revenues of \$14,226.1 million in 2024, representing a compound annual growth rate (CAGR) of 8.0% between 2019-24.
- Market consumption volume increased with a CAGR of 2.1% between 2019-24, reaching a total of 5,823.5 million liters in 2024.
- The UK carbonated soft drinks market registered strong growth during 2019-24, primarily driven by the post-pandemic rebound in out-of-home consumption, strong performance of low- and no-sugar variants, and aggressive premiumization across energy-infused carbonates, craft flavors, and functional sparkling drinks.
