- The Italian IT services industry recorded revenues of \$25.5 billion in 2024, representing a compound annual growth rate (CAGR) of 7.7% between 2019 and 2024.
- The infrastructure services segment accounted for the industry's largest proportion in 2024, with total revenues of \$17.2 billion, equivalent to 67.4% of the industry's overall value.
- In 2024, the Italian IT services industry recorded an annual growth of 9.5%. The growth is attributed to the accelerating digital transformation among small and medium-sized enterprises (SMEs). According to the European Commission, as of 2024, Italy had over 4.0 million SMEs. These SMEs lack the in-house technical expertise, leading to greater reliance on IT service providers for outsourced solutions.
