Summary

Key Highlights

- IT services market involves the design, development, implementation, management, and support of information technology systems and applications for organizations. Market values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that calendar year.
- The Russian IT services industry recorded revenues of \$11.9 billion in 2024, representing a compound annual growth rate (CAGR) of 6.9% between 2019 and 2024.
- The infrastructure services segment accounted for the industry's largest proportion in 2024, with total revenues of \$7.4 billion, equivalent to 62.3% of the industry's overall value.
- The expansion of Russia's IT services industry during 2019-24 was driven by strong government-led digital transformation efforts and rapid digitalization across sectors. For instance, in 2024, the Russian government allocated RUB2.5 billion (\$26.9 million) from its reserve fund to the Ministry of Digital Development, Communications, and Mass Media to subsidize preferential loans for IT firms engaged in digital transformation projects.
