- The expansion of the UK's IT services industry is driven by rapid enterprise digitalization, strong government support for technology-driven transformation, and rising adoption of cloud-based infrastructure. The government programs such as UK Digital Strategy, Made Smarter Programme, and AI Sector Deal are encouraging businesses to modernize operations and migrate to cloud and data center solutions, fueling demand for infrastructure services such as cloud computing, hosting, and managed security.
