- Market consumption volumes declined with a negative CAGR of 7.6% between 2019-24, reaching a total of 113.8 million units in 2024.
- The contraction of the French makeup market during 2019-24 is primarily due to economic challenges and the COVID19 pandemic. Despite traditionally high demand, makeup product sales declined from 2020 to 2022 due to lockdowns that kept people at home.
