- The Mexican soups market registered strong growth during 2019-24, primarily driven by rapid urbanisation and a growing middle class in Mexico boosted disposable incomes and increased the appeal of convenient meal solutions; as busy households and dual-income families expanded, packaged soups (instant, shelf-stable, and chilled) gained traction.
