- The North American soups market registered strong growth during 2019-24, primarily attributed to a combination of convenience-food tailwinds and pandemic-related effects. During the pandemic years, the appetite for home-consumed meals surged, and consumers increasingly turned to ready-to-eat and prepared meal solutions such as soups.
