- Market consumption volume increased with a CAGR of 3.3% between 2019-24, reaching a total of 51.1 million kilograms in 2024.
- The Dutch soups market registered healthy growth during 2019-24, primarily driven by evolving consumer behavior and favorable structural conditions. Dutch households increasingly sought convenience meal solutions, the rise of smaller households, busier work-lives, and interest in quick, easy-to-prepare meals meant that ready meals and soups proliferated.
