Summary

Suncare in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2019-24, and forecast to 2029). Key Highlights

- The suncare market includes the retail sales of sun protection, after-sun, and self-tan products. The sun protection segment includes lotion, spray, gel, or other topical products that absorb or reflect some of the sun's ultraviolet (UV) radiation. After-sun segment covers all mass and premium moisturizing creams formulated for sunburned skin. Self-tan segment includes all mass and premium products that either enhance natural tanning (tanning aids) or allow the skin to tan without exposure to the sun. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Asia-Pacific suncare market recorded revenues of \$4,923.1 million in 2024, representing a compound annual growth rate (CAGR) of 1.9% between 2019-24.
- Market consumption volume increased with a CAGR of 1.2% between 2019-24, reaching a total of 304.8 million units in 2024.
- The Asia-Pacific suncare market revenue contracted during 2019-24, caused by the COVID-19 pandemic, which resulted in lockdowns and travel restrictions across Asia-Pacific countries. The lockdown resulted in reduced outdoor activities, leading to a slowdown in the consumption volume and market revenue of suncare products.
