Summary

Suncare in Canada industry profile provides top-line qualitative and quantitative summary information including: market size (value 2019-24, and forecast to 2029). Key Highlights

- The suncare market includes the retail sales of sun protection, after-sun, and self-tan products. The sun protection segment includes lotion, spray, gel, or other topical products that absorb or reflect some of the sun's ultraviolet (UV) radiation. After-sun segment covers all mass and premium moisturizing creams formulated for sunburned skin. Self-tan segment includes all mass and premium products that either enhance natural tanning (tanning aids) or allow the skin to tan without exposure to the sun. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Canadian suncare market recorded revenues of \$174.5 million in 2024, representing a compound annual growth rate (CAGR) of 0.5% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 1.7% between 2019-24, reaching a total of 10.4 million units in 2024.
- The Canadian suncare market revenue grew at a slow pace during the review period 2019-24, caused by the COVID-19 pandemic, which resulted in lockdowns and travel restrictions. The lockdown resulted in reduced outdoor activities, leading to a contraction in consumption volume and slow revenue growth.
