The sun protection segment includes lotion, spray, gel, or other topical products that absorb or reflect some of the sun's ultraviolet (UV) radiation. After-sun segment covers all mass and premium moisturizing creams formulated for sunburned skin. Self-tan segment includes all mass and premium products that either enhance natural tanning (tanning aids) or allow the skin to tan without exposure to the sun. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The US suncare market recorded revenues of \$3,304.8 million in 2024, representing a compound annual growth rate (CAGR) of 7.0% between 2019-24.
- Market consumption volume increased with a CAGR of 2.8% between 2019 and 2024, reaching a total of 240.7 million units in 2024.
- The US suncare market revenue recorded healthy growth during the review period 2019-24, driven by rising awareness of the harmful effects of UV radiation, including ageing and skin cancer.
