- Within the aerospace & defense industry, China is the leading country among the BRIC nations with market revenues of \$30,665.9 million in 2024. This was followed by Russia, India and Brazil with a value of \$29,916.9, \$27,006.5, and \$2,465.8 million, respectively.
- Russia is expected to lead the aerospace & defense industry in the BRIC nations with a value of \$38,048.3 million in 2029, followed by China, India, Brazil with expected values of \$35,588.9, \$33,174.5 and \$2,412.1 million, respectively.
