- Within the hotels & motels industry, India is the leading country among the BRIC nations with market revenues of \$1,68,976.2 million in 2024. This was followed by China, Russia and Brazil with a value of \$1,45,411.6, \$26,322.9, and \$17,660.0 million, respectively.
- India is expected to lead the hotels & motels industry in the BRIC nations with a value of \$2,24,380.2 million in 2029, followed by China, Russia, Brazil with expected values of \$1,77,244.2, \$36,507.9 and \$23,809.1 million, respectively.
