The saw palmetto berries market size was valued at \$172.4 million in 2023 and is projected to reach \$325.7 by 2035, growing at a CAGR of 5.6% from 2024 to 2035.

Saw palmetto berries is the fruit of the *Serenoa repens* palm tree. Saw palmetto berries are small, dark purple drupes, known for their medicinal properties and historical use in traditional herbal medicine. Primarily, there are two types of saw palmetto extracts namely, oil-based extracts and powdered extracts. Saw palmetto berries contain bioactive compounds such as fatty acids, phytosterols, & flavonoids and are primarily used to promote prostate health & alleviate symptoms associated with benign prostatic hyperplasia (BPH). These berries are used in the production of dietary supplements, herbal teas, medicines, and topical creams.

Rise in demand for organic products is anticipated to drive the demand for saw palmetto berries owing to rise in consumer preference for natural and sustainable options. Organic saw palmetto berries, cultivated without synthetic pesticides, fertilizers, or genetically modified organisms (GMOs) which appeal to health-conscious consumers who seek products free from chemical residues and environmental harm. As awareness of the potential health benefits of organic foods and supplements increases, consumers are actively seeking out organic saw palmetto-based products as a safer and more environmentally friendly alternative to conventionally grown varieties. Moreover, this trend is particularly pronounced among segments of the population that prioritize organic and clean-label products, such as millennials and individuals with higher disposable incomes.

In addition, the organic certification of saw palmetto berries adds value to the product which has premium prices in the market. Consumers perceive organic certification as a mark of quality and authenticity, instilling confidence in the safety and purity of the product. This premiumization effect further drives market demand for organic saw palmetto berries by incentivizing growers and

Innovation in formulations presents numerous opportunities by enhancing product efficacy, bioavailability, and consumer demand for the saw palmetto berries. Manufacturers leverage advancements in technology and research to develop novel formulations that address specific consumer needs and preferences. For example, sustained-release capsules or time-release formulations extend the release of active compounds from saw palmetto extracts, ensure a steady supply of nutrients over time, and improve convenience for consumers. Moreover, this innovation enhances the effectiveness of saw palmetto supplements and differentiates them from traditional formulations & attracts discerning consumers seeking superior products.

Moreover, innovation in formulations allows manufacturers to explore new delivery systems and product formats that cater to diverse consumer preferences.
