- Non-life insurance is typically defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event.
- The Argentinian non-life insurance market recorded gross written premiums of \$11.0 billion in 2024, representing a compound annual growth rate (CAGR) of 7.2% between 2019 and 2024.
- The motor segment accounted for the market's largest proportion in 2024, with total gross written premiums of \$5.4 billion, equivalent to 49.1% of the market's overall value.
- In 2024, the Argentinian non-life insurance market recorded an annual growth of 4.5% due to the increasing frequency and severity of natural catastrophes, including wildfires and floods, which have elevated property risk exposure and forced both households and businesses to seek broader and higher-value coverage. For instance, in May 2025, severe rainfall in northern Buenos Aires province, a core Argentine agricultural region, triggered extensive flooding and the evacuation of thousands of residents.
