- The functional drinks market includes retail sales of sports drinks and energy drinks. Sports drinks are defined as drinks with performance-enhancing properties, described as 'isotonic', 'hypertonic', or 'hypotonic'. Energy drinks are defined as those with energy-enhancing properties; mainly carbonated and containing stimulants such as caffeine, taurine, guarana, glucuronolactone, yerba mate, along with glucose syrup (corn syrup) and maltodextrin. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Swiss functional drinks market recorded revenues of \$690.8 million in 2024, representing a compound annual growth rate (CAGR) of 10.2% between 2019-24.
- Market consumption volume increased with a CAGR of 4.8% between 2019-24, reaching a total of 97.3 million liters in 2024.
- The Swiss functional drinks market registered strong growth during 2019-24, primarily due to rising consumer demand for premium, wellness-oriented beverages, due to high per-capita income and increasing health awareness in Switzerland.
