- Non-life insurance is typically defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event.
- The Greek non-life insurance market recorded gross written premiums of \$2.9 billion in 2024, representing a compound annual growth rate (CAGR) of 4.7% between 2019 and 2024.
- The motor segment accounted for the market's largest proportion in 2024, with total gross written premiums of \$1.1 billion, equivalent to 39.9% of the market's overall value.
- In 2024, the Greek non-life insurance market recorded an annual growth of 7.8%. The growth is driven by an increase in net household disposable income, enabling consumers to allocate greater financial resources toward risk protection. According to Eurostat, in 2024, the net disposable income per household in Greece reached \$34,105.4, up 4.5% annually.
