- In 2024, the revenue of the global hotels & motels industry recorded an annual growth of 12.1%. The growth is attributed to the increase in both international and domestic visitors. According to the International Trade Administration (ITA), in 2024, the US attracted 72.4 million international visitors, a 9.1% increase from 2023.
