- In 2024, the Turkish advertising industry recorded an annual growth of 16.8%. The growth is attributed to the continued expansion of internet users, which has directly supported the growth of online advertising. According to the World Bank, in 2024, the number of internet users in Turkey reached 76.9 million, up 3.7% annually.
