- Among the G8 nations, the US is the leading country in the government spending industry, with market revenues of \$11,739.8 billion in 2025. This was followed by Germany and France, with a value of \$2,396.6 and \$1,921.2 billion, respectively.
- The US is expected to lead the government spending industry in the G8 nations with a value of \$14,410.0 billion in 2016, followed by Germany and France with expected values of \$2,966.4 and \$2,276.6 billion, respectively.
