Market volume and value represent consumption volume and value.
- All market data and forecasts are based on nominal prices, and all currency conversions used in the creation of this report have been calculated using yearly average exchange rates. The USD values may show a declining trend for a few countries, such as Argentina, Turkey, Nigeria, Egypt, and Russia. This is primarily because of the impact of exchange rates considered.
- The global paper & paperboard market recorded a revenue of \$396.8 billion in 2025, representing a compound annual growth rate (CAGR) of 3.2% between 2020 and 2025.
- Market consumption volume increased with a CAGR of 1.5% between 2020 and 2025, reaching a total of 4,18,289.8 million tonnes in 2025.
- The growth in paper & paperboard consumption during 2020-25 was driven by the rise in household disposable income.
