- Among the G8 nations, the US is the leading country in the paper & paperboard industry, with market revenues of \$69,499.9 million in 2025. This was followed by Japan and Germany, with a value of \$23,733.9 and \$14,204.5 million, respectively.
- The US is expected to lead the paper & paperboard industry in the G8 nations with a value of \$75,151.5 million in 2016, followed by Japan and Germany with expected values of \$26,143.9 and \$15,408.1 million, respectively.
